123 Apologies for Absence

Apologies were noted from Cllr Cooper-Marsh.

124 Declarations of Interest

There were none.

125 Minutes

RESOLVED to approve the minutes of the meeting of the Operations and Amenities Committee held on 10th March 2025 as a true and accurate record.

126 Action list

Members received the committee action list.

Members noted that the following actions had been completed;

- Museum roof and air conditioning unit repairs had been completed.
- Cleaning of War Memorials.
- Purchase of replacement operational vehicles with plug-in hybrid alternative.

Members noted that the museum building will be monitored over the coming months to assess the impact of recent repairs before considering any further work, to ensure that the most appropriate and cost-effective issues and solutions are identified and addressed.



127 Local Highway Initiative Bids

- i) Members received and considered a report from the Town Clerk, along with feedback from the recent Luke Street Local Highway Improvement (LHI) proposal consultation, provided by the Cambridgeshire County Council Highways Officer.

Members discussed the process for the Local Highways Initiative (LHI) bid, noting that once submitted, it would be reviewed by County Highways in consultation with the County Councillor for the area. With the upcoming County Council election, it was acknowledged that a new councillor could take a different view, potentially affecting the outcome of the bid. Some members suggested pursuing a less contentious option (Option 1), which focused solely on signage, although it would not fully address local congestion issues. Due to a low public response to consultations and the need for clearer input from the County Council, it was proposed and seconded to defer a final decision until after the election. However, some members raised concerns about the impact of further delays on project delivery.

RESOLVED to defer making a recommendation on how to proceed with the Luke Street and surrounding roads Local Highways Improvement bid until after the Cambridgeshire County Council elections and confirmation of the elected Ward Member who would work with Highway Officers to approve any scheme.

- ii) Members received and noted that a LHI bid for St Neots East and Gransden ward had been re-submitted to focus on a non-complex bid for a streetlight to improve safety in the vicinity of the Loves Farmhouse entrance. This had been identified by the Loves Farm Community Association as a priority matter which was more likely to get support through the LHI process.

128 Tree complaint

Members received and considered correspondence and supporting documentation from an agent acting on behalf of a resident, requesting the removal of a mature oak tree located on St Neots Town Council-owned land at Saxon Gate open space. The request was made on the basis of reported structural damage to a nearby property caused by the tree's roots.

Members noted that the Operations Manager had requested quotes for the removal of the tree, but these had not yet been received. Due to the size of the tree the cost may be considerable.



Members expressed their support for the removal of the tree on the grounds that the reports provided suggested damage was being caused to the property. Members commented that, while no formal liability currently exists, the tree's proximity to residential properties and the risk of future claims due to damage of foundations justified removal. Members agreed that awareness of potential risk now places a responsibility on the Council to act.

Members noted that a planning application would be required for the removal of the tree.

It was proposed and seconded that the Council agree to remove Oak tree T002 on the grounds the damage is being caused to the foundations of a neighbouring property (SNTC tree reference T030)

An amendment was proposed that the council will commit to planting replacement trees in a suitable nearby location as part of its ongoing environmental responsibility. The amendment was accepted.

RESOLVED that the Council agree to remove an Oak tree at Saxon Gate open space (T030) for which evidence has been provided that the roots of the tree are causing damage to the foundations of a residential property.

129 Solar Panels for St Neots Museum and Gate Lodge

Members received and considered recommendations from the Environment and Emergency Committee on the installation of solar panels on council owned buildings, along with a report and quotes from the Environmental Project Officer.

Members firstly debated installing panels at the museum building, which is owned by the Council and leased and operated by the Museum Trustees.

- a) Committee members expressed strong support for installing solar panels on the rear roof of the St. Neots Museum, viewing it as an obvious and worthwhile investment. The museum is a non-commercial, community-focused institution that already receives council funding, making it distinct from other properties under council ownership. A Member commented that since the council is already funding some repair and maintenance, court room electricity and grants for an event, the benefits of energy savings from the solar panels could reduce financial pressures and result in less funding requests to the Council. There was a brief discussion around battery storage—some councillors suggested the museum might struggle to fund this and proposed the council could consider covering it as well. However, the Town Clerk commented that the museum is open to the potential of contributing to the battery cost and could grant support for that. Planning concerns were also raised due to the museum's location in a conservation area, but reassurance was given that panels would be placed at the rear of the building and not visible from the High Street.



RESOLVED to RECOMMEND to the Finance and Governance Committee that the Council installs solar panels at the St Neots Museum building and that the Council funds the cost of the panels and battery.

RESOLVED to RECOMMEND that company B's quotation is recommended as the preferred company at a cost of £10,509.18.

Members moved to debate the proposed installation of solar panels on the Gate Lodge building, which is owned by the Council and leased to a commercial organisation.

- b) The proposal to install solar panels on Gate Lodge was debated. While council members supported the installation of panels on the building in principle, concerns were raised about using public funds to install infrastructure that would primarily benefit a private tenant. Several members argued that doing so could set a precedent for other commercial tenants expecting similar support. Others highlighted the environmental benefits and the Council's adopted Climate Action Plan which included actions on installing PV panels on buildings within the Council's estate, helping reach net-zero ambitions. Alternative funding models were suggested, such as increasing rent to recoup costs or offering an interest-free loan as part of a new lease agreement. It was noted that the current lease has a short period remaining, and any investment should be tied to renegotiating a longer lease. Councillors acknowledged that the building must eventually meet energy efficiency regulations, but consensus formed around the need to avoid direct taxpayer subsidy. It was proposed and seconded to recommend that the Council does not proceed with the installation of solar panels at this point but offers to negotiate an early renewal of the lease and explores the installation of solar panels through those negotiations.

RESOLVED to RECOMMEND that the Council does not proceed with the installation of solar panels on the Gate Lodge at this time but instead offers to enter into early lease renewal discussions with the tenant. These discussions should explore options to encourage the installation of solar panels—such as an interest-free loan or revised rent terms—to ensure any investment is recouped by the Council.

130 Heating Systems for Gate Lodge and SVDK Building A (Man Cave)

Members received and considered a report and estimated quotes from the Environmental Project Officer on the installation of new heating systems at:

- Gate Lodge
- SVDK Building A (Man Cave)



Members discussed the report and the Council's responsibility as landlord for both buildings. The recommendations for the replacement of the heating systems resulted from energy efficiency audits of Council owned buildings which were undertaken and considered by the Environment and Emergency Committee.

RESOLVED to RECOMMEND to the Finance and Governance Committee that the Council moves forward with the installation of the recommended new heating system at Gate Lodge and that Company C is selected as the preferred quotation at a cost of £5,783.50.

RESOLVED to RECOMMEND that the Council moves forward with the installation of the recommended new heating system at the Steve Van de Kerkhove Community Building and that Company C is selected as the preferred quotation at a cost of £4,071.00

RESOLVED to RECOMMEND that the replacement of electric heaters with air-conditioning units at Gate Lodge this is conditional to reagreeing/negotiate the lease for the building.

A Member expressed concerns around the insulation of the Steve Van de Kerkhove building and asked that options be investigated on how this might be improved.

131 CCTV Data

Members received and considered CCTV data from Huntingdonshire District Council for February 2025. Members asked that a list of cameras covered by the Council's CCTV agreement with HDC, for which the Council is paying are included with the next data report. Members commented that they would like to see how many incidents the cameras funded were picking up.

1. Purpose of the Report

- 1.1 To provide Members with feedback and feasibility comments received from a Highway Officer for the Council's 2025 Local Highway Improvement scheme submission for Priory Park and Little Paxton ward.
- 1.2 To seek a decision from the committee on whether it wishes to proceed with a Local Highways Improvement (LHI) bid for the location.

2. Recommendation

- 2.1 That the Committee considers the feasibility feedback (Appendix A) from the Highways Officer in relation to the Local Highway Improvement bid submitted for Longsands Road.
- 2.2 That the Committee resolve whether it wants to continue to the next stages of continuing with a scheme for the location on the basis of the Highway Officers feedback and proposals.

3. Background

- 3.1 At a meeting of the Operations and Amenities Committee held on 3 December 2024 the Committee resolved that the Town Clerk submit a 2025 Local Highway Improvement bid for Priory Park and Little Paxton Ward to address pedestrian safety concerns on Longsands Road - crossing a busy road in front of two schools and a main thoroughfare used by residents.
- 3.2 The Town Clerk submitted an application to the Local Highway Improvement scheme as agreed by the committee in January 2025.
- 3.3 As part of the first stage of the LHI process the application is assigned to a Highways Project Officer for consideration, review and feasibility. This is ahead of a more detailed scheme being developed for consideration and scoring against other applications by a review panel.
- 3.4 Feedback and feasibility has been received for Members consideration.

4. Information Supporting Recommendation

- 4.1 The Council had raised concerns about the safety of pedestrians, particularly children crossing and navigating the area of Longsands Road which sits between two school entrances.

4.2 A Highway Officer for Cambridgeshire County Council has considered the application and provided an initial feedback and feasibility report. This feedback is appended to this report (Appendix A)

5. Financial Implications

5.1 The Town Council has a revenue budget of £40,000 for the current financial year.

5.2 The Town Council has an earmarked reserve of an estimated £137,764 for Highways Improvements, this is subject to confirmation of year end revenue expenditure.

5.3 The total funds available for Highway Improvements are estimated at £177,764.

5.4 There are a number of LHI bids at different stages which will require Town Council funds in the future. These are summarised below.

1. Purpose of the Report

- 1.1 To provide Members an update on the Council's 2024 Local Highway Improvement scheme submission for Priory Park and Little Paxton ward which focused on creating accessible dropped kerbs at key locations.
- 1.2 To seek a decision on whether to provide additional funding to facilitate a dropped kerb highlighted as necessary as part of delivering the scheme.

2. Recommendation

- 2.1 That the Committee notes the scheme designs from dropped kerbs at Priory Lane and Tebbutts Road.
- 2.2 That the Committee recommends that the Council increase its contribution to the Town Centre dropped kerbs Local Highways Improvement scheme by £7,000 to create a dropped kerb at the location highlighted in section 4.3.2 as part of delivering a complete scheme.

3. Background

- 3.1 At a meeting of the Council held on 19 December 2023 it was resolved that the Town Clerk submit a 2024 Local Highway Improvement bid for Priory Park and Little Paxton Ward for the creation of better accessible routes in and around the town centre through the installation of dropped kerbs and pavement resurfacing. It was resolved that the Town Council contribution of up to 50% of the costs of implementing the bid.
- 3.2 Cambridgeshire County Council Highways have advised that resurfacing of pavement does not fall under the remit of the LHI scheme.
- 3.3 The submission to install dropped kerbing as part of creating improved accessibility to key locations in the Town Centre was successful and moved through to the design stage.
- 3.4 Designs for dropped kerbs located at Tebbutts Road and Priory Lane, which were put forward in the application have been provided as deliverable under the schemes available budget.
- 3.5 The application arose following engagement with Access in St Neots. The designs provided as deliverable under the scheme have been provided to Access in St Neots for comment as part of ensuring a deliverable scheme addresses the needs it set out to.

4. Information Supporting Recommendation

- 4.1 The cost of delivering the works set out in Appendix A and B is estimated to total £20,574. Under the LHI Scheme the maximum the County Council will contribute is £10,000. The Town Council resolved to commit up to 50% of the cost of delivering the bid, giving a total budget of £20,000 the Highway Officers have been working towards. This budget includes both construction and project/staff costs. The works set out in Appendix A and B are achievable in the budget.
- 4.2 Designs for dropped kerbs included within the scheme located at Priory Lane and Tebbutts Road are appended to this report.
- 4.3 Feedback has highlighted that;
- 4.3.1 The Tebbutts Road proposal would resolve the safety issues highlighted.
 - 4.3.2 The Priory Lane design includes only 1 dropped kerb, which creates a connection issue with the other side of the road. The dropped kerb proposed outside the Smiling Grape shop needs a corresponding safe crossing point at the corner of the Waitrose car park there is no pavement to walk on to get out of that car park.



- 4.4 In discussing the feedback with the Highways Officer it was agreed that installing dropped kerbs at the corner of the Waitrose car park would be a valuable addition to the scheme. Unfortunately, due to budgetary constraints, they are unable to include this location as part of the current works.
- 4.5 The estimated total cost for the proposed four locations are £17,447.36, excluding staff costs of £3,090.30. Given this, it is not currently possible to include dropped kerbs at the Waitrose corner. However, if the Town Council is able to provide additional funding above the 50%, this could be incorporated into the scheme.

5. Financial Implications

- 5.1 The Town Council has a revenue budget of £40,000 for the current financial year.
- 5.2 The Town Council has an earmarked reserve of an estimated £137,764 for Highways Improvements, this is subject to confirmation of year end revenue expenditure.
- 5.3 The total funds available for Highway Improvements are estimated at £177,764.
- 5.4 There are a number of LHI bids at different stages which will require Town Council funds in the future. These are summarised below.





1. Purpose of the Report

- 1.1 To provide Members with an update on the adoption of open space land at Medland Grove and the removal of a tree on land at Medland Grove which is in the existing ownership of the Town Council.

2. Recommendation

- 2.1 That the Committee note the progress of Saxon Gate/Medland Grove land adoption.
- 2.2 That the Committee resolves that the Council does not take on maintenance of the land until the legal work and transfer is completed.

3. Background

- 3.1 At a meeting of the Town Council held on 25th February 2025 the Council agreed to adopt and maintain open space land at Saxon Gate / Medland Grove from a developer. As part of adopting the land the Council will receive a one-off commuted sum of £30,000 to the Council for future maintenance if it agrees to adopt the land. A further sum of £4,800 will be receive to undertake work required to trees on the land that will be adopted.
- 3.2 The site/s comprise of open grassed areas, trees of missed ages and shrubs. At present Persimmon Homes report they have a contractor visit the site 20 times a year to cut the grass, litter pick and maintain the shrubs/hedges
- 3.3 The Town Clerk instructed solicitors to work with the developer's solicitors on the transfer. The developer will cover the Council's legal fees as part of this process.

4. Information Update

- 4.1 The Council's solicitors have received payment for their fees from the developer and legal work on transferring the land to the Council is underway.
- 4.2 Solicitors are currently reviewing and negotiating the draft transfer, and a report is due to be issued to the Town Clerk the week of 5th May 2025, this will highlight any points of clarification the solicitor may have or recommendations related to the transfer.

- 4.3 A request has been received from the developer that the Town Council takes on maintenance of the land immediately, upon receipt of the commuted funds while the legal work continues. It is likely that this is partly due to the start of the current grass cutting season.
- 4.4 The Council's solicitor has advised the Town Clerk that this awaits the completion of the legal transfer. It should not take long (assuming that the drafting of the transfer is reasonable) to complete the transfer and it is best to keep areas of responsibility clear.
- 4.5 The Town Clerk therefore recommends that the Council do not take on maintenance of the land at this stage and continues to work with solicitors to keep motivation on completing the Transfer as soon as possible, rather than possibly being left in an unclear situation where the Town Council is maintaining land and taking on risk when there is no formal document setting out the arrangement.

5. Financial Implications

- 5.1 The Council is to receive a one off £30,000 payment towards maintenance of the land to be adopted.
- 5.2 The Council is to receive £4,800 for the cost of work to trees required as part of adopting the land.




TOTAL CCTV INCIDENTS BY COUNCIL APRIL 2024 – MARCH 2025





TOTAL CCTV INCIDENTS: CRIME VS NON-CRIME % SPLIT











TOTAL CCTV EVIDENCE REQUEST & DOWNLOADS APRIL 2024 – MARCH 2025





TOTAL OUT OF HOURS CALLS RECEIVED APRIL 2024 – MARCH 2025









TOTAL CCTV INCIDENTS LINKED TO HBAC & CAMBAC APRIL 2024 – MARCH 2025

- Our CCTV Operators regularly achieve fantastic results, we would like to share several highlights captured over the last quarter.
- The following incident write ups include a mx of crime and non-crime across both councils.
- We have experienced some excellent results; from pro-active arrests to tracking down some of our most vulnerable residents; saving lives and preventing crime from the control room.



Incident 24044 – 10th April 2024 - PM

VULNERABLE MALE SPOTTED IN CITY CENTRE

Together with a city centre doorman, operators observed an elderly male who looked to be in very poor health. This information, along with the male's description and location, was relayed to police via the airwaves.

Officers were deployed and soon arrived on scene to check if the male was ok, they took him to hospital where he was found to be seriously ill and in need of medical care.

Compliments were received from police control for spotting him, they do not believe he would have survived much longer. This was a great outcome for the team and collaborative work carried out between CCTV and CAMBAC users in the city.

Incident 24236 – 19th April 2024 – RS, MO

COUPLE ARRESTED FOR DRINK DRIVING AND POSSESSION OF DRUGS

Operators observed a male and female enter a car; the male appeared to be drinking alcohol. The vehicle details and location were relayed to police over the airwaves, cameras were deployed to follow the car as it drove away.

The car was driven in the wrong direction along the Highstreet, operators also believe they observed the female passenger snorting drugs from the armrest of the vehicle. Observations were maintained as the couple travelled around the town in the vehicle, police were deployed.

The couple were stopped by police, asked to carry out breath-tests and arrested for being over the limit. After being searched they were also found to be in possession of drugs and driving without a licence or insurance. The vehicle was seized, and the couple taken into custody.



VULNERABLE MISSING PERSON FOUND

CCTV staff received details of a missing person, a vulnerable young female. Observations were made throughout the day until eventually they spotted a female matching her description in a city centre park area. Police were informed and cameras were deployed to track her location.

Police eventually arrived on scene and confirmed that this was the missing female they were looking for, she was taken home.



Operators received a call via the police airwaves, reporting a missing child in the city centre. The young female had been separated from her mother, her description was given, and cameras were quickly deployed.

After a short area search, operators located the child on the market square, her location was given to police, and they swiftly arrived on scene. The child and mother were soon reunited – a great result!



MALE ARRESTED FOR DOMESTIC ABUSE

The operator on duty overheard police mention a domestic incident in a known location, as we have cameras in the area they were deployed, and the police were made aware that we could assist if necessary. Police gave the operator a description of the male who had run away from the incident and asked for an area search to try and locate him.

Cameras were deployed and the suspect was spotted almost straight away, even though he had changed his clothing to avoid being located. This was relayed to police and his location was tracked until the police arrived, he was arrested for domestic abuse.

A great reactive incident result!



RE-ACTIVE INCIDENT – BIKE THEFT – CAMBRIDGE

BIKE THIEF ARRESETED

Operators spotted 3 males behaving suspiciously and looking very interested in a selection of bikes locked up in the city centre. 2 were riding bikes already but the third was on foot, they started checking all the bikes, looking at locks and moving along the length of the bike racks.

They soon moved along to another rack of bikes where they were then seen using a bike saddle to try and break a lock on a secured bike, police were made aware of the situation and dispatched officers. Observations were maintained.

The 3 males soon broke the bike lock and removed the bike from the rack, they were then followed by the cameras until police arrived on scene. As soon as the suspects spotted the police they cycled away, the operators followed them around the city centre until they entered the park. As it was nighttime operators couldn't see them in the dark, with little lighting nearby. However, when a group were seen illuminated by phone screens police were informed and were soon on scene. A short foot chase ended with 1 of the males being arrested and the stolen bike being recovered.

Incident 27558 – 25th October 2024 – PM, LT

4 X ARRESTED FOR DRUGS AND OFFENSIVE WEAPONS

Operators spotted a male acting suspiciously at the rear of a city centre premises, he was clearly seen holding a knife. He was soon joined by 2 other males also carrying large, machete type knives. Police were immediately informed over the airwaves and units were deployed.

One of the males left the scene in a vehicle, the licence plate and direction of travel were relayed to police, the car was soon stopped by officers and the male arrested for possession of a bladed article and having possession of class A drugs.

The other males left the original location on foot, operators used cameras to track their movements. Eventually they were all located and arrested. In total, 4 males were arrested for possession of offensive weapons and class A drugs.

Later, a police inspector called to thank CCTV staff for their help with this incident. A great result and dangerous weapons removed from the streets.



Cameras were deployed and operators were successful in locating her in the town centre, her location was given to the police and observations were maintained until police arrived.

Incident 29299 – 20TH February 2025 – PM, LT

PROLIFIC SHOPLIFTER ARRESTED

Operators spotted a male running along the High Street, carrying a large carrier bag full of goods. As he looked suspicious the operators observed where he was going next, they saw him stop alongside a row of bushes where he retrieved another bag, full of goods. Observations were maintained as playback was used to confirm this was the same male reported earlier in the day for shoplifting in the town centre.



Police were informed of the situation and observations continued. He was then seen entering another shop, shortly after he emerged from the shop carrying several large joints of meat. 
Police arrived on scene soon afterwards and arrested the male, operators assisted the officers locate the stolen goods from where they had been hidden.

Drug dealer caught red handed on CCTV

A drug dealer caught red handed on CCTV in Huntingdon has been jailed.

Aidan Graves was captured by CCTV operators in Market Hill to sit on a bench and hand over white powder to another man in exchange for cash at around 3am on 9 May.

Staff monitoring the CCTV contacted police and he was stopped in the High Street where he was found with three bags of white powder and other drug paraphernalia.

At Cambridge Crown Court on Friday (21 June), Graves, 25, of Floras Road, Littlehampton, was sentenced to 16 weeks in prison after pleading guilty to being concerned in the supply of cocaine and activating a suspended sentence.



A man who stole a bike from Huntingdon has been sentenced.

The victim contacted police on 10 August after his silver Carrera Vulcan bike was stolen from outside Sainsbury's in Germain Walk.

Officers reviewed CCTV and identified 39-year-old Danny Bygrave as being responsible.

At Huntingdon Magistrates' Court on Thursday (5 September), Bygrave, of Turner Road, Colchester, was sentenced to eight weeks in prison, suspended for a year. He previously pleaded guilty to two counts of bike theft and possession of a class A drug

PC Jack Hayden, who investigated, said: "For many people, a bike can be a lifeline and their only method of transport and/or their tool for exercise.

"We recognise the impact these thefts can have on people's lives and we're committed to catching those responsible and putting them before the courts."

A man who stole five bikes in Cambridge has been sentenced.

John Bruce Miller, 40, of Highdene Road, Cambridge, was captured on CCTV stealing the bikes, which were all locked, from Corpus Christi College, Downing College, Perry Cury, Severn Place and Sandy Lane between 28 May and 8 July.

He was also captured on CCTV stealing a pair of bolt croppers from B&Q in Newmarket Road on 6 July as well as goods including deodorant, coffee and frozen meals from Co-Ops in Perne Road, and Cambourne, and Nisa in Teversham Drift between 25 June and 6 July.

At Cambridge Magistrates' Court on Friday, Miller was sentenced to six months in prison, suspended for 20 months after pleading guilty to eight counts of breaching a criminal behaviour order and five counts of bike theft, five counts of theft from a shop and one count of criminal damage. He must also pay £100 compensation to the five bike theft victims.

Miller's Criminal Behaviour Order (CBO) runs until 25 April 2025 and states he must not:


- Be in possession of any pedal cycle or pedal cycle part without proof of ownership in the form of a verifiable receipt
- Be in possession of any article used to steal pedal cycles in a public place

PC Luke Upcott, from the Spree Offending Team, said: "We recognise the harm that is caused when a cycle is stolen and we're working hard to reduce cycle crime and put offenders like Miller before the courts."


In October 2022, a multi-agency Cambridge Cycle Crime Prevent Task and Finish Group was set up by Cambridge City Council alongside Cambridgeshire Constabulary, Camcycle, businesses, universities and community groups.

Together the group have implemented several initiatives to tackle cycle crime including educational campaigns and cycle parking security improvements as well as enhancing enforcement measures.

Drink driver caught on CCTV after drinking at Huntingdon pub

A man who was caught on CCTV drink driving has been disqualified for a year.

Kevin Readhead had been drinking pints of beer at a pub in Huntingdon on February 6 when a concerned member of staff alerted CCTV operators that he was likely to get in his car.


The 57-year-old was captured on CCTV driving along Brampton Road and was stopped by police as he pulled into his home in Williams Close, Brampton.

Readhead blew 51 at the roadside and went on to provide an evidential reading of 43 micrograms of alcohol per 100 millilitres of breath in custody. The legal limit is 35 micrograms.

At Peterborough Magistrates Court on Friday February 21, Readhead pleaded guilty to being in charge of a motor vehicle whilst unfit through drink.

He was disqualified from driving for a year and must pay an £80 fine.

Aggressive beggar who spat on a Cambridge resident has been jailed

An aggressive beggar who spat on a Cambridge resident in an unprovoked attack has been jailed.

Jason Allum, 38, of Edgecombe, Cambridge, was handed an indefinite Criminal Behaviour Order (CBO) in April 2023 with conditions "not to act in an anti-social or disorderly manner, that causes or is likely to cause nuisance, disruption or annoyance to any person in Cambridge" and enter an exclusion zone within the city.

Between 12 July and 2 August, Allum breached the conditions of his CBO 14 times which were all captured on CCTV.

On 27 July Allum spat on a woman, who was unknown to him, in Petty Cutty in an unprovoked attack.

At Cambridge Crown Court today (5 December), Allum was sentenced to two years and one month in prison after pleading guilty to 14 breaches of a CBO and common assault. His CBO remains in place.

Shop thief stole coffee machine and four handbags



A shop thief who stole a coffee machine and four handbags has been sentenced.

On 4 March, Shaun Burrows was captured on CCTV stealing the £399.99 Nespresso machine from John Lewis in Cambridge.

He took it from the shelf, walked out of the shop and put it on his handlebars before riding off without paying.


A few months later on 25 October he was witnessed by a member of staff and CCTV at TK Maxx in Market Street to steal four ladies bags worth almost £200.

The 47-year-old activated the alarm and was stopped from cycling off by a member of staff. Police officers on patrol nearby then arrested him.

At Cambridge Magistrates' Court on Thursday (28 November), Burrows, of Victoria Road, was sentenced to eight months in prison, suspended for 12 months, after pleading guilty to two counts of shoplifting. He must also carry out 150 hours unpaid work and pay John Lewis £379.99 in compensation.

PC Charis Sparkes, who investigated, said: "People often think that shoplifting is a victimless crime but it causes misery to shop owners and their employees. Frequent shoplifting often results in an increase in pricing which in turn affects us all."







TOTAL INCIDENTS BY CATEGORY – CAMBS CITY APRIL 2024 –MARCH 2025







TOTAL INCIDENTS BY CATEGORY – ST NEOTS APRIL 2024 –MARCH 2025







TOTAL INCIDENTS BY CATEGORY – ST IVES APRIL 2024 –MARCH 2025







TOTAL INCIDENTS BY CATEGORY – RAMSEY APRIL 2024 –MARCH 2025






CCTV CAMERA MAP – CAMBRIDGE CITY AS OF MARCH 2025






CCTV CAMERA MAP – HUNTINGDON & GODMANCHESTER AS OF MARCH 2025






CCTV CAMERA MAP – ST IVES & HOUGHTON AS OF MARCH 2025






CCTV CAMERA MAP – ST NEOTS AS OF MARCH 2025




CCTV CAMERA MAP – RAMSEY AS OF MARCH 2025




Ramsey Cameras – 14 cameras




CCTV CAMERA MAP – YAXLEY AS OF MARCH 2025






CCTV CAMERA MAP – STILTON AS OF MARCH 2025


